3. The rate quoted shall be FOR Aizawl inclusive of all taxes. The tenderer should mention the rates clearly in figures as well as in words. Cutting/ overwriting of the rates shall summarily be rejected.

The selected dealer/agent shall be able to supply the required items in good condition and within 30 days from the date of issue of the supply order, which however may be extended depending upon the nature of difficulties, and any items which is found damaged at the time of received shall summarily be rejected. The dealer/agent shall have to deposit Rs.50,000.00 (Rupees fifty thousand only) in the form of KVP or any other National Saving Certificates as security which will be forfeited if fails to supply within the stipulated period.


