TERMS AND CONDITIONS ON QUOTATION FOR SUPPLY & INSTALLATION OF AIR CONDITIONERS UNDER DIRECTORATE OF LAND REVENUE & SETTLMENT

- 1. Quotations must be in sealed cover superscribed "QUOTATION FOR SUPPLY & INSTALLATION OF AIR CONDITIONERS UNDER DIRECTORATE OF LAND REVENUE & SETTLEMENT" and shall be addressed to the Director, Land Revenue & Settlement, Govt. of Mizoram.
- 2. Quotations shall be received upto 1:00pm of 15th September and shall be opened at 2:00pm the same date. Any, quotation received after the due date shall be summarily rejected.
- 3. Quotation must be accompanied by upto date House Tax Payee Certificate (HTPC) in respect of Scheduled Tribe and Court. Fee Stamp worth Rs.7/-(Rupees seven) only for Non-Tribal (GST) quotations. A photocopy of Government registration Certificate should also be furnished in the quotations.
- 4. The rate quoted shall be FOR Aizawl and inclusive of all taxes. The quotationer should mention the rates clearly in figures and in words. Overwriting of the rates shall be summarily rejected.
- 5. Quotation must be accompanied by an earnest money of Rs. 2000/(Rupees two thousand) only in the form of Call Deposit/Bankers Cheque
 from any recognized Bank in favour of Director, Land Revenue &
 Settlement and the same shall be released only after satisfactory
 completion of supply. The earnest money in respect of non-selected
 quotationers shall be released immediately.
- 6. Selected quotationer shall have to complete supply and installation of the air Conditioners within 30 (thirty) days from the date of issue of supply order. They should submit the exact materials (same make, type, quality etc) as submitted by the quotationer and
- 7. Any defective items shall be replaced free of cost.
- 8. The Local Purchase Committee under Directorate of Land Revenue & Settlement is not bound to accept the lowest quotation and has the right to accept to reject any or all quotations without assigning any reasons thereof.
