NOTIFICATION

In exercise of the powers conferred under Section 75A(4) of the Mizoram (Land Revenue) Act, 2013 (*herein after referred to as 'the said Act'*), the Governor of Mizoram is pleased to notify, retrospectively w.e.f. dt.23.09.2022, that 15 percent share of the Government as stipulated under sub-section (1) and (2) of Section 75A of the said Act shall be collected from land acquisition made under the following Acts:

1. The Indian Telegraph Act, 1885
2. The National Highways Act, 1956
3. The Petroleum and Mineral Pipelines (Acquisition of Right of User in Land) Act, 1962
4. The Railways Act, 1989
5. The Electricity Act, 2003
6. The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013
7. The Mizoram (Land Acquisition, Rehabilitation and Resettlement) Act, 2016.
8. 15 percent share of the Government shall also be deducted from the award not yet pronounced even if notification for acquisition was issued under any land acquisition Act by the Union or State as stipulated under sub-section (5) of Section 75A of the said Act.

The share of the Government so collected shall be utilized for the purpose of land administration and other ancillary purposes as stipulated under sub-section (3) of Section 75A of the said Act.
