Inthlan puan a nih atanga Land Revenue & Settlement Department a hnathawk zawng zawngten an zawm ngei tur thil pawimawh tam tak zingah heng a hnuai ami te hi ngaih pawimawh hmasak nise:-

- 1) Court Order bawhzuia thil tih tul te leh ram teh (demarcate) leh verification te chu buaipui chhunzawm zel a ni ang a. Approval tak erawh chu pek rih loh tur a ni.
- 2) House site / LSC etc., dilna dawn theih reng a ni a, dilna form pawh dan pangngaiin pek chhuah theih reng a ni.
- 3) Sawrkar thil (hei hian Department website thlengin a huam) leh hmun hmaah unauthorised political advertisements, banga ziaak emaw poster emaw paper a tar emaw, cutouts, hoarding, banner, flag etc te chu remove vek tur a ni vide GAD's instruction No. B.12021/1/2024-GAD dt.21.03.2024 and ECI No. 437/6/1/INST/ECI/FUNCT/MCC/2024 dt.20.03.2024.
- 4) Advertisement chhuah/function programme huaihawt, a dangte tih dawnin Administrative Department kaltlangin Screening Committee-ah phalna lak hmasak zel tur a ni.
- 5) Extension of land area dilna atana ram teh (demarcate) kalpui zel a ni anga, Government approval erawh pek rih loh tur a ni.

- 6) Mutation/Ownership transfer application hi ram allotment thar a ni lova, heng hi chu kalpui chhunzawm theih a ni ang.
- 7) Partition chungchangah application dawn tawh te chu kalpui chhunzawm theih a ni ang.
- 8) Amalgamation of land pawh ram allotment thar a ni lova, kalpui chhunzawm theih a ni ang.
- 9) Heng partition, amalgamation leh amalgamation with partition dilnate hi kalpui a, approval erawh chu Election zawh fel hnu ah consider chauh tur a ni.
- 10) LSC/Land Pass/Land Lease area correction hi kalpui chhunzawm tur a ni.
- 11) He Order hi Land Revenue & Settlement Department a thawk zawng zawngte hnenah Officers concerned ten hriattir vek tura tih a ni.
