## **NOTIFICATION**

No. H. 11018/8(a)/2020-REV: In supersession to all the Notifications already issued in this regard and in exercise of the powers conferred by sub-section (2) of Section 47B of the Indian Stamp Act, 1899 (Act No.2 of 1899) as applicable in Mizoram; the State Government hereby constitutes Valuation Sub-Committee for the Districts of Aizawl, Lunglei, Champhai, Kolasib, Serchhip, Mamit, Saitual, Hnahthial and Khawzawl under the Chairmanship of the Deputy Commissioner/District Registrar of the District concerned for estimation, publication and revision of market value guidelines of properties in any area in the District, comprising the following members, namely:

- (a) Secretary, Finance Department or his representative;
- (b) Secretary, Law & Judicial Department or his representative;
- (c) Municipal Commissioner, Aizawl Municipal Corporation or his representative for Aizawl District;
- (d) Chief Executive Officer, Lunglei Municipal Council or his representative for Lunglei District;
- (e) Superintending Engineer, Public Works Department or his representative;
- (f) District Urban Development Officer or his representative;
- (g) Project Director, District Rural Development Office or his representative.
- (h) Deputy Commissioner of State Tax, Taxation Department or his representative.
- (i) Settlement Officer/Asst. Settlement Officer, Land Revenue & Settlement Department or his representative;
- (j) District Local Administration Officer or his representative;
- (k) District Officer, Land Resources, Soil & Water Conservation Department or his representative;
- (l) District Research Officer, Economics & Statistics Department or his representative;
- (m) President, Federation of Mizoram Chamber of Commerce and Industries or his representative;
- (n) President, Sub-Headquarters, YMA or his representative.
- (o) Any other two persons nominated by the Valuation Sub-Committee.

- (2) The Sub-Registrar of the District Headquarters shall be the Member Secretary of the Valuation Sub-Committee and shall be responsible for looking after the day-to-day administration and functions of the committee and other matters relating to correspondence. He shall also be responsible for compilation and publication of the data relating to the market value guidelines in accordance with the decision of the Committee.
- (3) The office of the Valuation Sub-Committee shall be located in the office of the District Registrar or any other place decided by the Valuation Sub-Committee.
