**NOTIFICATION**

**No. H.11018/1/2019-REV:** WHEREAS the Mizoram (Land Acquisition, Rehabilitation & Resettlement) Act, 2016 (hereinafter referred to as the MLARR Act, 2016) was declared as inapplicable in the State by the Gauhati High Court, Aizawl Bench in its order dt.30.10.2024 in W.A. 70 of 2018;

AND WHEREAS the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (hereinafter referred to as the RFCTLARR Act, 2013) was adopted by the Fourth Session of the Ninth Mizoram Legislative Assembly held on dated 11<sup>th</sup> March, 2025 and notified vide even No. dt.28.03.2025;

NOW, THEREFORE, the Governor of Mizoram is pleased to hereby notify with immediate effect and until further order, that -

- (1) All land acquisition projects initiated under the MLARR Act, 2016 where Preliminary Notifications had already been issued shall henceforth be proceeded as per the provisions of the RFCTLARR Act, 2013.
- (2) For all the land acquisition proceedings where Social Impact Assessment (SIA) study was conducted but Preliminary Notifications are not issued yet, the Preliminary Notifications shall be issued under the RFCTLARR Act, 2013 as are recommended by the Expert Groups. The conduct of SIA study shall be deemed to have been done under the RFCTLARR Act, 2013.
